

Procedures for registering vehicles and drivers:

In order for a trucking company to register vehicles and trailers the following source documents will be required

- 1. A written request for truck/trailer loading documented on a company letterhead with details of the authorized person to act on behalf of the company.
- 2. A certified copy of the truck and trailer license registration documents
 - 3. A certified copy of the company Vat registration certificate/CK1
- 4. A certified copy of the drivers licence and ID (Passport if not SA citizen)
 - 5. A certified copy of works permit for all non SA citizens
 - 6. Completed application forms
 - 7. <u>Vehicles and Drivers moving hazardous cargo must be certified and documents must be produced.</u>
 - 8. RIB licenses must be handed in
 - 9. <u>Truck/trailer registrations will be linked to the trucks/trailer license</u>
 <u>expire dates thus meaning that when the truck/trailer license expires the</u>
 <u>truck/trailer will not be allowed in the terminal until renewal has been</u>
 <u>provided</u>
- 10. <u>BAT numbers will be allocated to each vehicle per contractor which must placed in a visible position for the machine operator to see when executing loading or offloading.</u>
 - 11. Valid permit to enter terminal will be issued (applies to new registrations)

Procedure for changing or deleting vehicles/drivers

- An official letter of request from the trucking company to delete or change any details
 - 2. A certified copy of the truck/trailer registration documents
- 3. <u>Terminal access permit must be handed in for cancellation when vehicles are deleted.</u>
