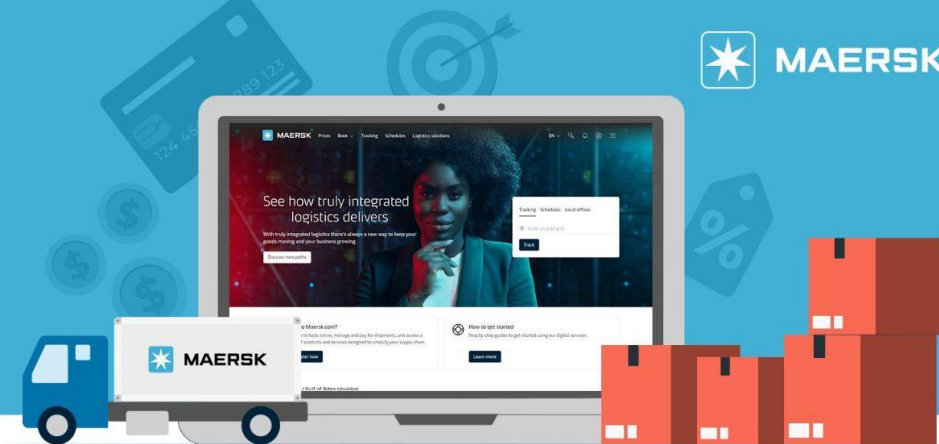
STEP #2 Search the Shipment Number from your Hub dashboard

Electronic Cargo Release (ECR)



Electronic Cargo Release (ECR) will help you to request telex via website instead of requesting via e-mail or call. Customers only need to settle the payment of Telex Fee and don't have to surrender the OBL + LOI anymore. Request for ECR can be placed on a shipment from any cargo originating country. The restriction applies to some of the destination countries and there will be notification as below so you unable to choose ECR.

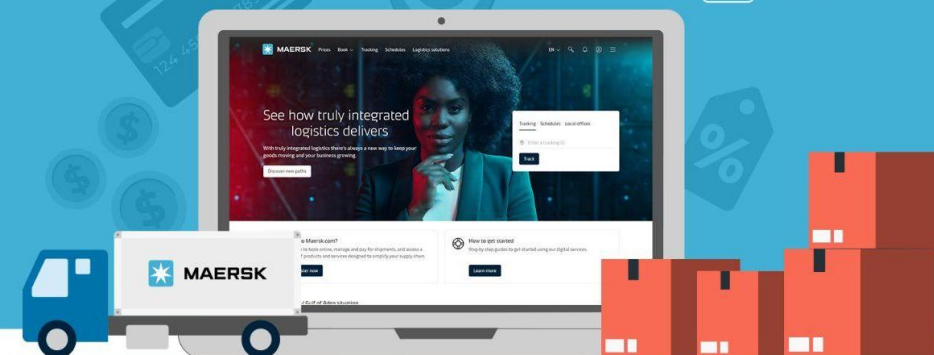
