



Announcement of LCL Local Charges in Japan / South Korea (effective date: 2024/06/15)

Dear Values Customers,

Maersk wishes to announce our new Free Time for LCL in Japan, which shall be applied for all LCL shipments to be carried by Maersk LCL with effective from 2024/09/02, unless otherwise specifically stated. The change is highlighted in red.

<Northeast Asia LCL Local Charge Tariff>

- * Customs clearance fee or other unforeseen charges are NOT included.
- * DDP is NOT acceptable in South Korea when it comes to Import shipment.
- * Global standard for "Non stackable" price is to use universal multiplier 1.5x.
 - A. Universal multiplier **1.5x** are applicable to standard charge which are charged on WM / CBM basis, including **origin, ocean freight and destination** part.
 - B. The **1.5x** multiplier is not applicable to charge items based on shipment level.
