- Incorrect Pre-Advice details will also incur a shut-out charge and if not settled containers will be offloaded.
- **Port of Discharge** to be declared on Navis should always be **discharge port of first transshipment port**.
- Kindly ensure to strictly follow cut offs pertaining to Arrastre payments, Export Document submission, Pre-Advise, Storage and Terminal Fees settlement.
