Amendment process (Post Arrival)

After manifestation filling in Pakistan customs (48 hours before vessel arrival), if customer need amendment in existing/manifested data, it has to go through post arrival amendment process procedure.

Consignee or any party requesting for amendment has to provide below mentioned list of documents along with undertaking. Revised BL is mandatory requirement by Pakistan Customs to telex release will not work here origin need to assign IOTD task to destination so that BL can handover directly to consignee.

Undertaking from new consignee	Undertaking on 100/- bond paper by the new importer (with copy of CNIC of owner / witnesses) wherein they have undertaken / take responsibility regarding loss of revenue	
Freight forwarder request	Freight forwarder request addressing to assistant / deputy collector of customs requesting for amendment (in case of involvement of freight forwarder).	
Export Cargo Manifest/Certificate from Origin/LC, ETC	All related/supported document like LC, Bank Remittance Certificate Contract need to be ready for customs amendment
